## **EXECUTIVE DIRECTOR REPORT- A. Higginbotham**

- Last week important dates were circulated around upcoming meetings
- CEBA Loans
  - O OBIAA has been advocating on an extension
  - There is now an extension to January 18th, 2024 for repayment
  - WDBIA is assisting in this advocacy
- 5 years of Digital Main St Grant is being celebrated
  - March 2024 the project will fi nish no word of extension as of now
  - There is a possibility the portal may re-open, funding pending
  - Those who have not yet applied are still encouraged to apply and they will remain in the cue for this funding
  - Tiana will present this project at the upcoming AGM
  - Discussion around the pros & cons, barriers, limitations and the experience of this program
- The region was not approved for Main st construction for 2024, therefore is postponed to 2025. This included the Niagara St Bridge
