REPORT OF THE CHAIR- J. D'Hulster

- AfroCaribbean Festival took place last weekend
- Breeze Nutrition Bar has Grand Opening this month
- Welland Zombie Walk is coming up again this fall

EXECUTIVE DIRECTOR REPORT- L. Carr

- Busy month, focus on stakeholder engagement
 - o Eblast
 - Newsletter
 - o In person
- Lee, Brenda and Katia have been working on response to draft city plan- acknowledged Brenda's time and work
- New levy roll- 160 addresses captured, 70 are vacant- Lee spoke with the city and there will be a call to
 action in relation to CIP
- Upcoming BIA 2025 annual proposed budget will be shared with the city by September 15th
 - C. Speck asked for clarification on what we are sharing and schedule
 - Lee responded with details
 - O. C. Setaram noted we have time to make some requests and asked what the ED is thinking. Items have been discussed, such as beautification and more. Asked what are we planning for 2025 in addition, ie social media support, ect. What needs to we have to better serve?
 - K. Joaquin asked for clarification to affirm our budget will be unchanged from 2024,
 - Lee responded that Aug 15 deadline is for a brief email email, Sept 15 is for a detailed budget
 - K. Joaquin noted we should ask for more than the levy
 - O K. Jones noted that the city is asking for this 2-3 month early, traditionally this is done after the AGM and assured the budget will reflect the strat plan, recommends a levy increase in the budget
 - Lee responded that we will continue to try to engage interns and Canada Summer Jobs for social media
- Breeze Nutrition Bar has Grand Opening this month, offering support, Mayor and MP will be present
- Sept 30th is Truth & Reconciliation Day- Tori has reached out to inform Lee about their plans, Lee has
 reached out to the FENFC for engagement, he is happy to offer support, unsure of what that will be
- Working with POP committee for funding opportunities

GOVERNANCE COMMITTEE- K. Jones

- Working with Quite Alright to finalize the Strat Plan design that will get shared with our members and beyond, will be ready by September
- A board applicant has been brought forward- Archie Spagnolo from Breeze Nutrition Bar

- C. Speck responded we need to be conscious of a raise in rate to stakeholder
- Discussion was had around the idea to expand our catchment. And increase relating to inflation will be considred
